The conference explored a range of different aspects of migration and diaspora in the countries that once formed part of the Soviet Union, as well as those states and cultures that border the former superstate. While the emphasis of the conference was on current, post-Soviet, trends, these were always viewed from a historical perspective, with a strong awareness of the legacies of the Soviet past. The conference explored migration in Eurasia from a macro- as well as micro-perspective. It looked at contemporary migration policies and the practicalities of its implementation; it tackled questions of national, ethnic, migrant and diasporic identity; it deconstructed representations of migrants and diasporas; it explored the problems of memory and politics, gender and labour, education and integration; it examined issues of social status, mobility and networking. Gathering together sociologists, anthropologists, historians, geographers and political scientists from France, Germany, Russia, Kazakhstan, Australia, the US, Canada and the UK, it presented a uniquely wide-ranging, cross-disciplinary forum for informed discussion of issues that are of enormous topical significance.
